## SITE RULES — PLEASE READ

Disregard of site rules, or any unsafe or illegal behaviour will result in your immediate expulsion from Intention 12

1. **Alcohol and drugs are not permitted on site.**
2. Campers must provide their own bedding and towels.
3. NO pets are allowed at the camp other than guide dogs.
4. NO candles or incense are allowed in any Camp buildings
5. Smoking is only permitted in the designated area.
6. All indoor and outdoor fires must be approved by the Camp
7. The Camp is a completely nut free facility, and is used regularly by children with life-threatening nut allergies.
8. NO food is to be consumed in the Lodges or Recreation centre. Please bring all food and snacks to the dining hall.
9. Leave no trace: everything you bring, take it away
10. Parents/guardians are responsible for their children/dependents at all times.
11. Participants will be responsible for any damages caused by themselves or their dependents

**INTENTION 12 RELEASE AND WAIVER OF LIABILITY**

WARNING: THIS DOCUMENT WILL AFFECT YOUR LEGAL RIGHTS READ IT CAREFULLY

In consideration of being permitted to participate in any way in an event to be held Thursday December 30th to Monday January 3rd, at the Zajac Ranch for Children ("Intention 12") without limitation **I HEREBY WAIVE ANY AND ALL CLAIMS** that I have or may in the future have against, and **RELEASE FROM ALL LIABILITY AND AGREE NOT TO SUE**, the following parties:

- (a) ALL INTENTION 12 ORGANIZERS together as a group and as individuals;
- (b) all Zajac Ranch for Children Staff, Management and Board of Directors and the staff, management and Board of Directors of The Mel Jr. & Marty Zajac Foundation
- (c) any INTENTION 12 workshop facilitators, coordinators, or assistants, and ("collectively, the Facilitators"),
- (d) any and all other participants at INTENTION 12 (collectively, "the Peer Participants"), each of their estates, heirs, executors, trustees, committees or administrators,

(all of the above, collectively, the "**Releasees**") for any loss, property damage, expenses or personal injury (including death) that I may suffer, or that my next of kin may suffer, as a result of my participation in INTENTION 12 **DUE TO ANY CAUSE WHATSOEVER ON THE PART OF THE RELEASEES, INCLUDING:**

- **Negligence** (the meaning of which includes failure to use such care as a reasonably prudent person would use under similar circumstances and the failure to meet standards of care imposed upon those engaging in INTENTION 12 Activities for the safety or comfort of other participants);
- **Breach of any other duty imposed by law;**
- **Breach of contract;**
- **Mistakes or Errors in Judgment** by the Releasees, including, without limitation, mistakes or errors in judgment that may affect my safety.

**IN ADDITION, I AGREE TO INDEMNIFY AND HOLD HARMLESS** the Releasees from any and all liability, loss, or damages (including attorney's fees) they may suffer as a result of claims, demands or judgments against them arising out of any injury or damage that I either cause or suffer during my participation in INTENTION 12.

**I AM AWARE THAT THERE ARE CERTAIN SPECIFIC RISKS INHERENT IN PARTICIPATING IN INTENTION 12 INCLUDING BUT NOT LIMITED TO:**

**POTENTIALLY HAZARDOUS TERRAIN – WATER HAZARDS – WEATHER – FIRE PERFORMANCES** – including planned and unplanned fire performances that may be supervised or unsupervised or organized or not by the INTENTION 12 organizers or may be conducted solely by some other Peer Participant;

**CONDUCT OF THE RELEASEES** - the conduct, including NEGLIGENCE, of the Releasees;

**PROXIMITY OF MEDICAL CARE** - which may not be readily available or effective; and

**PARTICIPATION IN INTENTION 12 ACTIVITIES** - that may challenge participants' physical or emotional boundaries, and which may involve outdoor activities, terrain hazards, use of the swimming pool, hot tub or other electrical equipment, fire or fuel hazards.

**I AGREE** that, although the Releasees or third parties are taking reasonable precaution to reduce the risks and increase the safety of any of the INTENTION 12 Activities, it is not possible to make the INTENTION 12 Activities completely safe or free from risk. I willingly accept **PERSONAL RESPONSIBILITY** for all the risks and dangers of participating in the INTENTION 12 Activities. **I accept and understand that the participants and individuals associated in any way with assisting in the organization of INTENTION 12 have done so of their own free will and with only the most innocent of intentions. I respect that the event in which I am about to participate would not happen without my personal involvement and I accept the same level of responsibility of all participants and organizers.**

I willingly consent to the terms of this Agreement even if the Releasees are found in law to be negligent or in breach of a duty of care or any other obligation to me during the course of the INTENTION 12 Activities. In entering into this Agreement I am not relying on any oral, visual or written representations or statements made by the Releasees with respect to the safety or comfort of the INTENTION 12 Activities other than what is set forth in this Agreement.

I agree that this waiver and the agreements it contains will be governed in all respects by, and interpreted exclusively in accordance with, the laws of the Province of British Columbia, Canada and I irrevocably attorn solely to the exclusive jurisdiction of the courts of the Province of British Columbia, Canada.

I agree that if any portion of this Agreement is found to be void or unenforceable, the remaining portions of this agreement shall remain in full force and effect.

I confirm that I am at least nineteen years of age and that **I HAVE READ AND UNDERSTOOD THIS AGREEMENT** prior to signing it and agree that this Agreement will be binding upon my heirs, next of kin, executors, administrators, assigns and representatives in the event of my mental or physical incapacity or death. I further confirm that the terms and conditions of this Agreement will apply to any minor that is under my care and control and that accompanies me to INTENTION 12 and that I am the legal guardian or parent of any minors that I bring to INTENTION 12 and as such I have the authority to sign this document on his or her behalf
